A report can be made by calling **8-800-5-432-4453**, 24 hours a day, 7 days a week, 365 days per year. A Case Manager will respond to your call quickly and gather necessary information needed to assess the child's safety.

Mandated Reporters also have three additional CPCS reporting options. Please identify one CPCS reporting option per family:

**Option 1 (Fax):** Complete your report on the CPCS mandated reporter website at <https://fpcr.dhs.state.ga.us/report>. If you are using this option and received an auto-reply from the website, please do not use other reporting options. We will process the report based on verified facts provided on call you at the number you have on your report if we need additional information. Before you can register on the mandated reporter website, you must take a short, free online mandated reporter training offered by Pro-Solutions Training at <http://www.pro-solutions.com/training.aspx>.

**Option 2 (Fax):** E-mail the report to [suspectedchildabuse@doj.state.ga.us](mailto:suspectedchildabuse@doj.state.ga.us). You will receive an auto-reply stating that the CPCS report has been received. This will require a return address containing 24 hours of contact information as directed. Close the report in word or pdf and e-mail it to [suspectedchildabuse@doj.state.ga.us](mailto:suspectedchildabuse@doj.state.ga.us). You will receive an auto-reply from the mandated reporter letterbox as soon as the e-mail address you registered on the CPCS website with. This requires you to add the legal requirement to report with a CPCS employee. Please include on the report an envelope return your copy back to us.

**Option 3 (Email):** Fax to **309-217-4962**. Close the report in word or pdf and e-mail it to [suspectedchildabuse@doj.state.ga.us](mailto:suspectedchildabuse@doj.state.ga.us). You will receive an auto-reply from the mandated reporter letterbox as soon as the e-mail address you have on your fax. You will receive an auto-reply within 24 hours if auto-reply is forwarded to mandated reporter. This return address must contain the legal requirement to report with a CPCS employee. Please include on the report an envelope return your copy back to us and your name and address. To request a PDF version of this CPCS form or issue dated reporter letter, please contact [publicinfo.services.officer@doj.state.ga.us](mailto:publicinfo.services.officer@doj.state.ga.us).

Please note that you may be called for additional information regarding this report.

All reporters have the ability to make an anonymous report. Your information will be kept confidential and will not be shared. If court action is initiated, the case record may be subpoenaed as a result of your proceedings and the reporter cannot be assured confidentiality will be fully protected. It may be necessary for you to appear in court to protect the child. All reporters are immune from liability when the report is made in good faith.
