FINGERPRINT RIDGE PATTERNS

Loops

60% of prints



Loops are the most common fingerprint pattern. They enter from one side, curve around a central point, and exit on the same side. There are three types: Ulnar Loop, Radial Loop, and Double Loop.

Whorls

30% of prints



Whorls are circular or spiral patterns. They are the second most common fingerprint pattern. There are three types: Plain Whorl, Central Whorl, and Double Whorl.

Arches

10% of prints



Arches are the least common fingerprint pattern. They enter from one side, rise in the center like a wave, and exit on the opposite side. There are two types: Plain Arch and Waviness.

Ridge Pattern	Count	Notes
Ulnar Loop	1	is shape, points toward ulna (thumb)
Radial Loop	1	is shape, points toward radius (index)
Plain Whorl	1	is shape
Double Loop Whorl	1	is shape
Central Plain Whorl	1	is shape, points toward center
Double Whorl	1	is shape, points toward center
Arch	1	is shape, points toward center
Double Arch	1	is shape, points toward center
