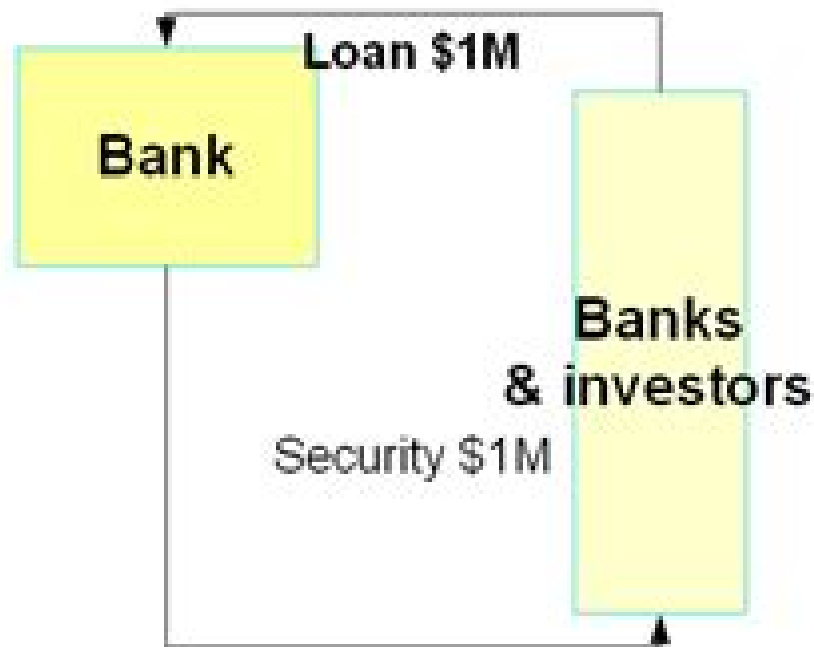
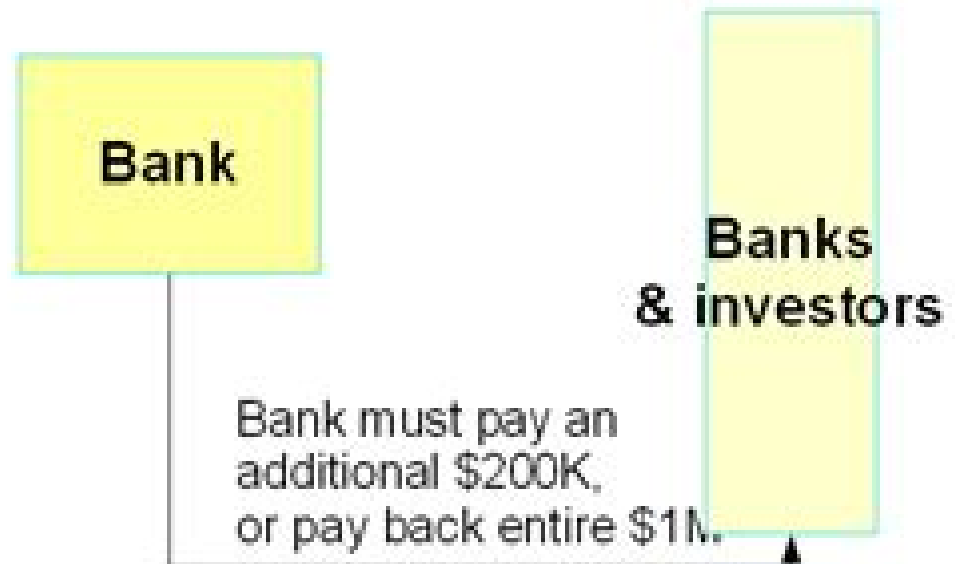


Repo Haircuts are like Withdrawals
